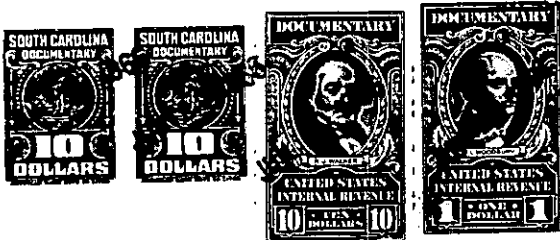
KNOW ALL MEN BY THESE PRESENTS, that I, Agnes S. Forrester,

unto Orville L. Hedden and Robbie Jo R. Hedden, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Mayflower Avenue and being known and designated as Lot No. 5 on plat of Pecan Terrace recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 9, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Mayflower Avenue at the joint front corner of Lots Nos. 5 and 6 and running thence along said Avenue N. 17-33 E. 70 feet to an iron pin; thence along the joint line of Lots Nos. 4 and 5 S. 72-27 E, 150 feet to an iron pin; thence S. 17-33 W. 70 feet to an iron pin; thence along the joint line of Lots Nos. 5 and 6 N. 72-27 W. 150 feet to the point of beginning.
