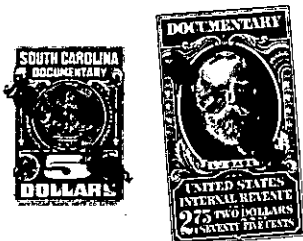
KNOW ALL MEN BY THESE PRESENTS, that Poinsett Realty Company
