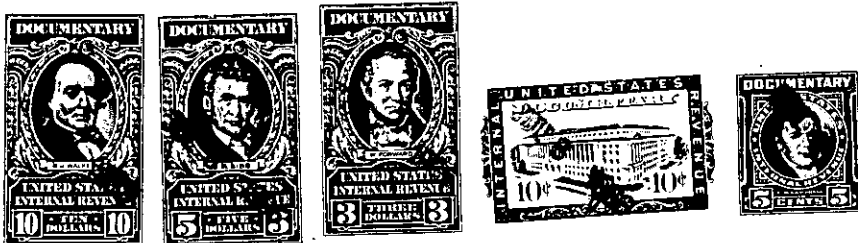

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto BERT T. AND CAROLYN HUNT, THEIR HEIRS AND ASSIGNS FOREVER:

ALL of that lot of land in the County of Greenville, State of South Carolina, near Travelers Rest, S.C., known as Lot No. 29 and a portion of Lot No. 28 and a portion of Lot No. 30 on Plat of Brookgreen, recorded in Plat Book MM, page 41 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Dell Circle at the joint front corners of Lot No. 28 and No. 29 and running thence S 72-18 E 50 feet to an iron pin; thence through the center of Lot No. 28, N 17-42 W 180 feet to an iron pin; thence N 72-18 E 180 feet to an iron pin on the western side of Dell Circle; thence with said circle, S 17-42 E 130 feet to an iron pin; thence along the curve of the circle, the chord of which is S 38 W 70.6 feet to an iron pin; thence S 72-18 W 80 feet to the point of beginning and being a portion of that property conveyed to me in Deed Book 307, page 7.
