KNOW ALL MEN BY THESE PRESENTS, that we, Franklin L. Chamblee and Carolyn G. Chamblee

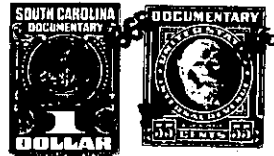
in consideration of Five Hundred and no/100----- Dollars,
