in consideration of Two Thousand Six Hundred (\$2,600.00) Dollars,

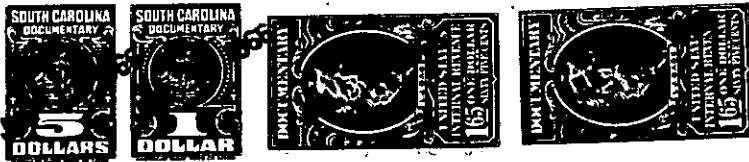

All that piece, parcel, or lot of land, with the buildings and improvements thereon, in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 88 of Hunters Acres, and having, according to a plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BB, Pages 50 and 51, the following metes and bounds to-wit:

BEGINNING at a point on the eastern side of Boyd Avenue at the joint front corner of Lots Nos. 88 and 89, and running thence with the joint line of said Lots, S 80-00 E 192.7 feet to an iron pin on the bank of the branch; thence running along the meanders of said branch as a line, the traverse line being N 40-26 E 92.7 feet to an iron pin at the joint rear corner of Lots Nos. 87 and 88; thence with the joint line of said Lots, N 80-00 W 239.8 feet to an iron pin at the joint front corner of said Lots on Boyd Avenue; thence with the eastern side of Boyd Avenue, S 10-00 W 80 feet to the point of beginning.
