KNOW ALL MEN BY THESE PRESENTS, that DREXEL, INC.

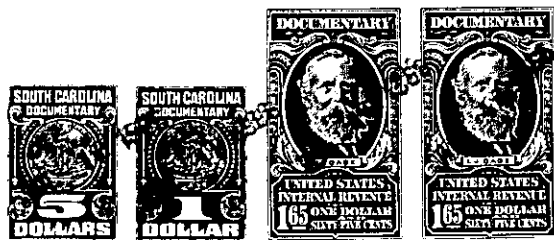
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Two Thousand Nine Hundred Fifty and No/100 (2,950.00) * * * * * Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto R. V. Chandler and Company, Inc., its Successors and Assigns,

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 29 on plat of Drexel Terrace dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the office of the R. M. C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the southerly side of Dellrose Circle, joint front corner of Lots 29 and 30 and running thence along the common boundary of said lots S. 22-38 W. 220 feet to a point, joint rear corner of said lots; thence turning and running N. 61-23 W. 100.6 feet to a point, joint rear corner of Lots 28 and 29; thence turning and running along the common boundary of said lots N. 22-38 E. 209.5 feet to a point on the southerly side of Dellrose Circle, joint front corner of Lots 28 and 29; thence turning and running along the southerly side of Dellrose Circle S. 67-22 E. 100 feet to the point of beginning. This lot is subject to a drainage easement along a portion of the joint line of Lots 28 and 29 as shown on the recorded plat.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the R. M. C. for Greenville County in Deed Book 671 at page 355 and to building setback line as shown on said plat.

This is a portion of the property conveyed to the grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R. M. C. for Greenville County in Deed Book 671 at page 155.
