KNOW ALL MEN BY THESE PRESENTS, that I, C. E. Duncan

in consideration of One (\$1.00) Dollar and desire to aid in work of grantee ~~XXXXXX~~

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Tabernacle Baptist Church (White Horse Road), its officers, their successors and assigns, all my undivided one-half (1/2) interest in and to the following described property:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the former site of the Odd Fellow's Orphanage, about four miles southwest of the City of Greenville, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of a 20 foot private road at a point 355.2 feet from the northwestern corner of the intersection of said private road with the Old Easley Bridge Road, and running thence S. 47 W. 180 feet to an iron pin; thence N. 43 W. 120 feet to an iron pin; thence N. 47 E. 180 feet to an iron pin on the southwestern side of said private road; thence along the line of said private road, S. 43 E. 120 feet to the beginning corner.

This being the same property conveyed to the grantor by deed of Maude R. Jordon, dated November 5, 1964, recorded in the RMC Office, Greenville County, in Deed Book 761, at page 96.

As a part of the consideration hereinabove expressed, the grantee herein assumes and agrees to pay one-half of the balance on the note and mortgage indebtedness owing as of this date on an obligation executed by Russell D. Jordan and Maude R. Jordan to Carolina Federal Savings and Loan Association, of record in Mortgage Book 843, at page 210, in the RMC Office, Greenville County, South Carolina.
