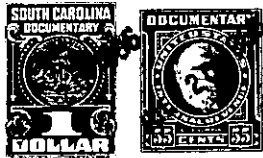

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto O'DELL L. GRAHAM, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina and being one-half of Lot No. 6 in Section "C" of a subdivision known as Sunny Slope as per plat made by R. E. Dalton, Engineer, May, 1919, and recorded in the R.M.C. Office for Greenville County in Plat Book F at Page 86, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Fortner Street at corner of Lot No. 5 and running thence with the line of Lot No. 5, S. 9-48 W., 135.7 feet to iron pin on First Avenue; thence with First Avenue N. 66-11 W., 25.75 feet to stake; thence N. 9-48 E., 129.5 feet, more or less, to stake on Fortner Street; and thence with the south side of Fortner Street S. 80-05 E., 25 feet to beginning corner."

The above described lot of land is a portion of the same conveyed to me by Lou Mae Elder by deed dated March 2, 1949 and recorded in Book 374 at Page 280.
