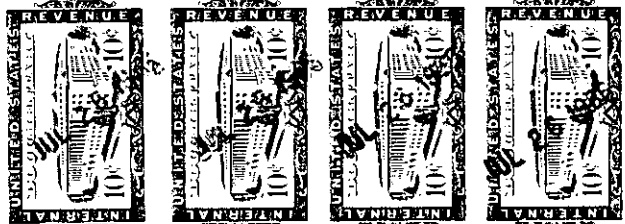

All that lot of land, with the buildings and improvements thereon, situate at the south-west corner of intersection of Edwards Road and Valerie Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 1 and a portion of Lot 2 on Plat No. 2 of Liberty Park, made by Dalton & Neves, Engineers, August 1953, revised December 1958, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book MM, Page 39, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of Valerie Drive at joint corner of Lots 1 and 2 and running thence through Lot 2, S. 62-09 W. 151.3 feet to an iron pin in the rear line of Lot 2; thence N. 20-15 W. 169.2 feet to an iron pin on the south side of Edwards Road; thence with the south side of Edwards Road, N. 56-20 E. 125.7 feet to an iron pin; thence with the curve of Edwards Road and Valerie Drive, (The chord being S. 71-57 E. 34.2 feet) to an iron pin on the West side of Valerie Drive; thence with the west side of Valerie Drive, S. 20-15 E. 133.5 feet to the beginning corner, being the same conveyed to the grantor herein by deed dated February 25, 1966 and recorded in the R. M. C. Office for Greenville County in Deed Book 792, Page 526.
