KNOW ALL MEN BY THESE PRESENTS, that We, Lawrence B. Morgan and Frances M. Morgan

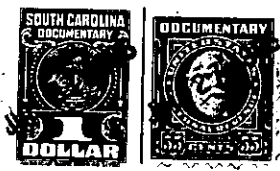
in consideration of ----- FIVE HUNDRED and NO/100 (\$500.00)----- Dollars,

ALL THAT piece, parcel or lot of land, situate, lying and being in Greenville County, South Carolina, known and designated as Lot 9, Block C, as shown on a plat entitled Brookforest Subdivision, said plat being recorded in the RMC Office for Greenville County in Plat Book "BB", at Page 41 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Southwest side of Westbrook Lane; joint corner of Lots 8 and 9, thence along the line of Lot 8, S. 55-42 W. 175 feet; thence N. 34-18 W. 70 feet; thence along the line of Lot 10, N. 55-42 E. 175 feet to the Southwest side of Westbrook Lane; thence S. 34-18 E. 70 feet along said lane to the beginning corner.
