All that piece, parcel or lot of land situate, lying and being in or near the Town of Piedmont, Greenville County, State of South Carolina, being known and designated as Ejector Station No. 3 as shown on a plat prepared by John C. Smith, dated June 14, 1966, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 000 at page 50 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the Northwestern corner of the premises herein described which iron pin is located S. 12-29 E. 66.5 feet from the joint corner of property of Joe Couch and Cecil Bracken and running thence with the line of other property of the grantor herein S. 70-30 E. 55 feet to an iron pin; thence continuing with the line of other property of the grantor herein S. 19-30 W. 70 feet to an iron pin; thence still continuing with the line of other property of the grantor herein N. 70-30 W. 55 feet to an iron pin; thence still continuing with the line of the other property of the grantor herein N. 19-30 E. 70 feet to the point of beginning.
