All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Welcome Avenue, known and designated as Lot No. 1 of Section I of Oak Crest as shown by plat thereof made by C. C. Jones, and recorded in the Greenville County R. M. C. Office in Plat Book "GG" at pages 110 and 111 and having, according to said plat, the following metes and bounds:

BEGINNING at a pin on the south side of Welcome Avenue at the corner of the subdivision property line and running thence with the south side of Welcome Avenue, N. 60-02 E. 65 feet to a pin at corner of Lot No. 2; thence with line of Lot No. 2, S. 29-58 E. 150 feet to a pin in rear line of Lot No. 35; thence with rear lines of Lots Nos. 35 and 36, S. 60-02 W. 105.8 feet to a pin on subdivision property line; thence with said line, N. 15-00 W. 155.9 feet to the beginning corner; being the same conveyed to us by the grantees by deed dated June 14, 1963 and recorded in the R. This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage in the original sum of \$ 9,650.00 executed by Virginia K. Lollis to First Federal Savings and Loan Association of Greenville and recorded in Mortgage Book 812, at Page 414, having a balance of \$ 8,240.00 as of this date.
