M. R. L. Peden devised certain real estate to her three children, namely, John T. S. Peden, Lila P. Sprouse, and Lizzie Peden (see record in office of Judge of Propate, Greenville County, Apt. 319, File 3) to go to said children in three equal shares. John T. S.
