in consideration of Two Thousand (\$2,000.00) Dollars,
and assumption of mortgage
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Eugene V. Rosenau,

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate on the east side of LeGrand Boulevard, near the City of Greenville, in the county of Greenville, state of South Carolina, being shown and designated as Lot No. 1 on plat of Sherwood Forest, which plat is recorded in the RMC Office for Greenville County, in plat book GG pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of LeGrand Boulevard at the joint front corner of Lots 1 and 2, and running thence with the line of Lot 2, N. 88-30 E. 150 feet to an iron pin; thence S. 1-30 E. 62 feet to an iron pin; thence S. 45-55 W. 116.8 feet to an iron pin on the east side of LeGrand Boulevard; thence along the curve of LeGrand Boulevard (the chord of which is N. 46-16 W.) 65.4 feet to an iron pin; thence still with curve of LeGrand Boulevard (the chord being N. 16-28 W.) 70 feet to an iron pin; thence continuing with the east side of LeGrand Boulevard, N. 1-30 W. 27.2 feet to the beginning corner.

This is the same property conveyed to grantors by Thurman W. Power and Nelbe G. Power by deed recorded Aug 31, 1961 in vol. 681 page 126 of the RMC Office for Greenville County, S. C., and is conveyed subject to recorded easements, restrictions or rights of way.

The grantee herein assumes and agrees to pay that certain mortgage given by grantors to General Mortgage Co. in the original amount of \$13,300 which has been properly executed and recorded in the RMC Office for Greenville County, S.C. in mortgage vol. 867 page 311, on which there is a balance due of \$11,891.67
