KNOW ALL MEN BY THESE PRESENTS, that Norman P. McCarter and Linda Gayle McCarter

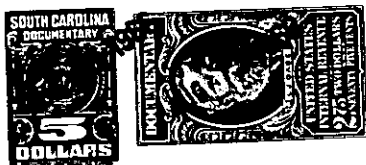
in consideration of Twenty-Five Hundred and no/100 -----(\$2500.00) Dollars,
