I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Marie Loviona Thomas

on or about the 12th day of July in the year of our Lord nineteen hundred and Sixty Six exhibited her complaint in the County Court for the County aforesaid, against Miss Callie Thomas, et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 4th day of August 1966, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for the County aforesaid, to Marie Lawson Thomas

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. J-7507)

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Marie Lawson Thomas

"ALL that piece, parcel or tract of land, situate, lying and being in Austin Township, County of Greenville, State of South Carolina, and having according to a Plat of the Property of W. M. Satterfield, dated December 28, 1954, the following metes and bounds, to-wit:

BEGINNING at a point in the center of Scuffletown Road and running thence along the line of the Arthur Lawson property N. 82-45 W. 962 feet to a stone and running thence along the line of the Arthur Lawson and the F. D. Hunter property S. 23-00 W. 1650 feet to an iron pin at the common corner of F. D. Hunter Property and the Huit Property; thence N. 70-25 E. 446.8 feet to an iron pin; thence continuing along the Huit property S. 80-00 E. 530.6 feet to a point in the center of a county road, thence along said county road N. 13-15 E. 264 feet to a point in said road; thence S. 75-00 E. 335.9 feet to a stone and an iron pin at the corner of the Hugh Cooper Property; thence along the Hugh Cooper Property N. 16-15 E. 712.3 feet to an iron pin; thence N. 78-52 E. 281 feet to a point in the center of Scuffletown Road; thence along the center of Scuffletown Road N. 23-32 W. 465 feet to the point of beginning. Said tract contains 35.75 acres.
