All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, being known and designated as Lot No. 115 in the subdivision known as Eastdale Subdivision, plat of said subdivision being recorded in the R. M. C. Office for Greenville County, in Plat Book YY at Pages 118 and 119 and being more fully described as follows:

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.



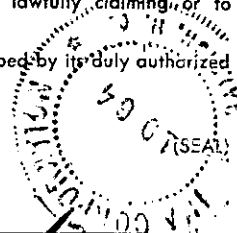
