James Thomas Webb, his heirs and assigns forever:

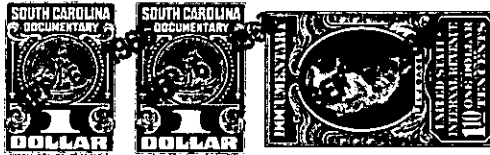

C. in Plat Book BB, at pages 22 and 23 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Alpine Way, said pin being the joint front corner of Lots 27 and 28 and running thence with the common line of said Lots N 50-41 W 175 feet to an iron pin; thence S 39-19 W 75 feet to an iron pin, joint rear corner of Lots 28 and 29; thence with the common line of said Lots S 50-41 E 175 feet to an iron pin on the northwesterly side of Alpine Way; thence with the northwesterly side of Alpine Way N 39-19 E 75 feet to an iron pin, the point of beginning.
