KNOW ALL MEN BY THESE PRESENTS, That I, H. D. QUINN

in the State aforesaid, in consideration of the sum of One Thousand Five Hundred and No/100 (\$1,500.00) Dollars to me in hand paid at and before the sealing of these presents by Lloyd Gilstrap

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said LLOYD GILSTRAP, his Heirs and Assigns, forever:

ALL that lot of land situate on the south side of Quinlan Way near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 6 on plat of Quinlan Acres, made by Jones Engineering Services, August 16, 1966, recorded in the RMC Office for Greenville County, S. C. in Plat Book _____, Page _____, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Quinlan Way at the joint front corner of Lots 5 and 6 and runs thence along the line of Lot 5 S. 2-28 E. 267.1 feet to an iron pin; thence S. 84-45 W. 163 feet to an iron pin; thence N. 6-44 W. 168.7 feet to an iron pin; thence N. 33-11 E. 200 feet to an iron pin on the south side of Quinlan Way; thence with the curve of Quinlan Way (the chord being S. 49-09 E. 80 feet) to the beginning corner.

This is a portion of that property conveyed to me by deed of B. D. Quinn, et al, recorded in Deed Book 260, Page 233.

This property is conveyed subject to the following restrictions:

1. This property shall be used solely and exclusively for a single family residential dwelling.
2. No residence shall be located on said lot nearer than 45 feet to the front lot line along Quinlan Way or nearer than 10 feet to any side lot line.
3. No residence shall be erected on said lot with a ground floor area of less than 1200 square feet exclusive of open porches and garage.
4. No trailer, basement, tent, shack, garage, barn or other outbuildings erected upon said lot shall be at anytime used as a residence temporary or permanent. No structure of a temporary nature shall be used as a residence. No house-trailers shall be permitted on this lot.
5. No livestock, cattle, swine, sheep, goats, chickens, ducks, geese, or other such fowls and animals shall be kept on said lot.
