forever:

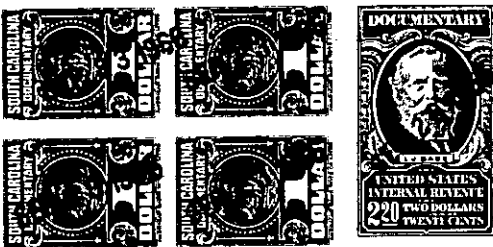
ALL that lot of land with improvements lying on the Norther side of Blossom Drive in Greenville County, South Carolina, being shown and designated as Lot No. 14 on a Plat of KENNEDY PARK, made by Piedmont Engineers & Architects, dated September 28, 1964, revised January 28, 1966, and recorded in the RMC Office for said County and State in Plat Book JJJ, page 179, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Blossom Drive at joint front corner of Lots 14 and 15 and running thence N. 2-42 E., 132.9 feet to an iron pin; thence N. 87-37 W., 75.1 feet to an iron pin; thence along the line of Lot No. 13, S. 2-42 W., 132.4 feet to an iron pin on the Northern side of Blossom Drive; thence along the Northern side of Blossom Drive, S. 87-18 E., 75 feet to an iron pin at the beginning corner.

The above described property is hereby conveyed subject to restrictions applicable to Kennedy Park recorded in the RMC Office for Greenville County, S. C., in Deed Book 773, page 527, and to rights of way and easements applicable to Kennedy Park shown on the aforementioned recorded plat and appearing of public record.

As a part of the consideration for this deed, the Grantees assume and agree to pay in full the indebtedness due on a note and mortgage covering the above described property in favor of Carolina Federal Savings & Loan Association recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 1040, page 571, which has a present balance due in the sum of \$8,400.00, plus accrued interest.
