KNOW ALL MEN BY THESE PRESENTS, that I, Jesse A. Singleton, of the County and State aforesaid,

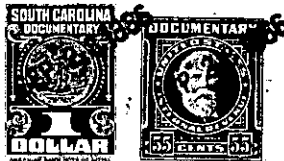
in consideration of Two Hundred (\$200.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Arthur B. Mathis, his heirs and assigns forever, the following described property, to-wit:

All that certain piece, parcel or tract of land situated in Dunklin Township, in the County of Greenville, State of South Carolina, as shown on a survey made by J. C. Hill, Registered Surveyor, dated July 27th, 1966, which is recorded in the R. M. C. Office for Greenville County, in Plat Book _____, page _____, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwestern corner of this tract, and Hi Cooley's property, and running thence N. 72-15 E. 188.9 feet to an iron pin, joint corner of this tract and property of Jesse A. Singleton; thence N. 60-30 W. 185.9 feet to an iron pin, joint corner of this tract and Singleton's property; thence S. 64-30 W. 122 feet with the Singleton line to an iron pin; thence continuing with the Singleton line S. 57-10 W. 212.8 feet to an iron pin, joint northwestern corner of this tract and Hi Cooley's property; thence with the Hi Cooley line, S. 59-30 E. 151.8 feet to an iron pin, the point of beginning, and containing ninety-five one-hundredth of an acre, more or less.

The above described tract being a portion of the same property conveyed to the grantor by Wilson J. and Lucille L. Stanton by deed dated October 15, 1960, and recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 661 at page 119.
