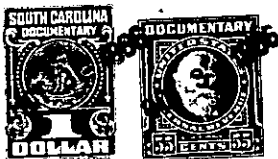
in consideration of Two Hundred and no/100 (\$200.00) ----- Dollars,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, in the Millford Church Community, being bounded on the northern side by lands of Pruitt, on the east and southern side by lands of J. H. Grant, and on the western side by an old road and lands of others, and having the following courses and distances, to-wit:
