KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Sitton, Trustee

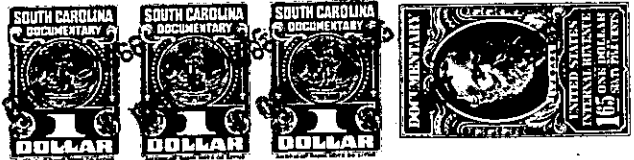
