ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Twelve (12) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book JJJ at page 71; and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the North side of East Seven Oaks Drive at the joint front corners of Lots 11 and 12 and continuing along East Seven Oaks Drive N44-41 W. 70 feet to an iron pin; thence continuing along East Seven Oaks Drive N41-21 W. 45 feet to an iron pin; thence turning and running N4-10E. 35.3 feet to an iron pin on a future street; thence continuing along this future street N 49-14 E. 168.1 feet to an iron pin; thence turning and running along the rear lot line of Lot No. 12 S 40-04 E. 80 feet to an iron pin; thence continuing along the rear lot line S 39-25 E 40 feet to an iron pin at the joint rear corners of Lots 11 and 12; thence turning and running along the joint lot lines of Lots 11 and 12 S 43-03 W. 187 feet to the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol. 784 at page 329.
