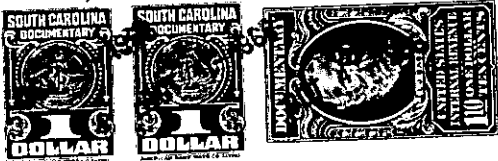
KNOW ALL MEN BY THESE PRESENTS, that I, Ulysses M. McClure
