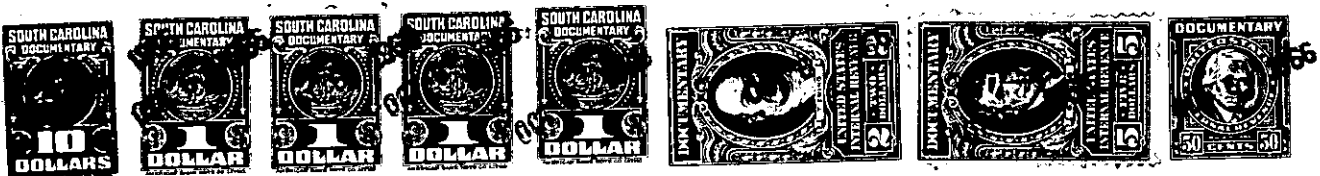
KNOW ALL MEN BY THESE PRESENTS, that I, John M. Hayes

and assumption of mortgage  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Robert Bowman McCorkle, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being on the westerly side of Dargan Avenue near the City of Greenville in the County of Greenville, State of South Carolina being known and designated as a portion of Lot No. 9 on a plat of property of Talmer Cordell and James H. Campbell recorded in the R. M. C. Office of Greenville County in Plat Book Z, page 175 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Dargan Avenue, joint front corner of Lot Nos. 8 and 9, said pin being 675 feet in a southeasterly direction from an iron pin on the southwesterly intersection of Dargan Avenue and Florida Avenue Extension, and running thence S. 75-47 W. 175 feet to an iron pin; thence S. 14-13 E. 65 feet to an iron pin; thence N. 75-47 E. 175 feet to an iron pin on the westerly side of Dargan Avenue; thence along the westerly side of Dargan Avenue N. 14-13 W. 65 feet to an iron pin; the point of beginning.
