ALL that piece, parcel or lot of land in Fairview Township, Greenville County, State of South Carolina, on the east side of Reedy River on the Georgia Road, having the following metes and bounds according to a plat made by, J. A. Adams, Surveyor, December 22, 1909.

BEGINNING at a stone 3x in the Georgia Road and running thence with said road N. 64-1/2 E. 7.02 chains to a bend in road; thence N. 67-1/4 E. 12.60 chains to bend in road; thence N. 75-1/4 E. 1.47 chains to a stone 3x; thence N. 25-1/4 E. 3.00 chains to bend in old road; thence S. 25-3/4 E. 7.50 chains to bend in old road; thence S. 25-1/2 E. 2.16 to bend in old road; thence S. 33 E. 3.50 chains to bend in old road; thence S. 33-1/4 E. 7.14 chains to bend in old road; thence S. 43-3/4 E. 14.30 chains to bend in old road; thence S. 37 E. 1.95 chains to bend in old road; thence S. 45-3/4 E. 8.00 chains to bend in old road; thence S. 34-1/4 E. 3.20 chains to stone 3x; thence S. 42-1/4 W. 28.61 chains to stone 3x in line of tract No. 2 as shown on said plat; thence with the line of tract No. 2 N. 29 W. 61.20 chains to the beginning corner, being known as tract No. 3 of the lands formerly owned by Edward Harrison, S.
