the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto

LORA IRENE HART KELLY, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, and being in Bates Township near Travelers Rest, South Carolina according to a plat prepared by Carolina Engineering and Surveying Company on the 25th day of July, 1966, recorded in the R.M.C. Office for Greenville County in Plat Book NNN at Page 74 and being known and designated as Lot No. 4, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the joint front corner of Lots Nos. 5 and 4 on Tigerville Road and proceeding thence N. 10-54 W., 201.8 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 4; thence N. 87-47 E., 101.8 feet to an iron pin at the joint corner of Lots Nos. 3 and 4 on Shelton Road; thence along Shelton Road S. 10-54 E., 200 feet to an iron pin at the corner of Shelton Road and Tigerville Road; thence S. 88-37 W., 100 feet along Tigerville Road to the point of beginning."
