KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County,

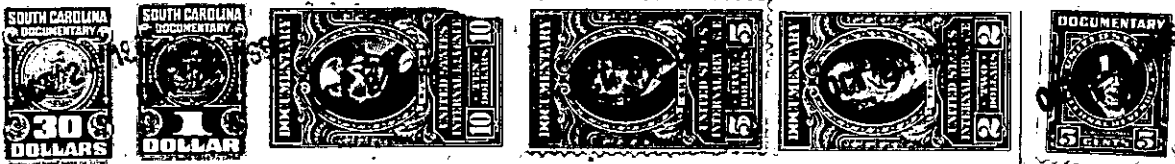
in consideration of Fifteen Thousand, Three Hundred Fifty and No/100 (\$15,350.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William S. Allen and Rita M. Allen, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot 17 of a subdivision known as Colonial Hills, Section 3 as shown on plat thereof prepared by Piedmont Engineers and Architects, dated May 7, 1965, recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 91 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Creighton Street, joint front corner of Lots 16 and 17 and running thence along the joint line of said lots, S. 80-15 E. 160.0 feet to an iron pin; thence N. 9-45 E. 100.0 feet to an iron pin at the rear corner of Lot 18; thence along the line of that lot, N. 80-15 W. 160.0 feet to an iron pin on the eastern side of Creighton Street; thence along the eastern side of Creighton Street, S. 9-45 W. 100.0 feet to the beginning corner; being the same conveyed to me by Williams Land Company by deed dated August 26, 1966 and recorded in the R. M. C. Office for Greenville County.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.
