All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 32, Pine Hill Village, as shown on plat prepared by R. K. Campbell, R.L.S., dated November 30, 1960, recorded in the R.M.C. Office for Greenville County in Plat Book QQ at page 169 and having according to said plat the following metes and bounds:

BEGINNING at an iron on the southeastern side of the cul de sac at the eastern terminus of Kennedy Drive at the joint front corner of Lots Nos. 31 and 32 and running thence with the line of Lot No. 31 S. 24-31 E. 118 feet to an iron pin at the joint rear corner of Lots Nos. 2, 3, 31 and 32; thence with the rear line of Lot No. 2 S. 86-50 E. 70 feet to an iron pin in the rear line of an unnumbered lot; thence with the rear line of certain unnumbered lots N. 8-47 E. 116.8 feet to an iron pin at the joint rear corner of Lots Nos. 32 and 33; thence with the line of Lot No. 33 N. 77-13 W. 110 feet to an iron pin on the eastern side of the cul de sac at the eastern terminus of Kennedy Drive; thence with the southeastern side of the aforesaid cul de sac and following the curve thereof, the chord of which is S. 45-38 W. 40 feet, to the point of beginning.
