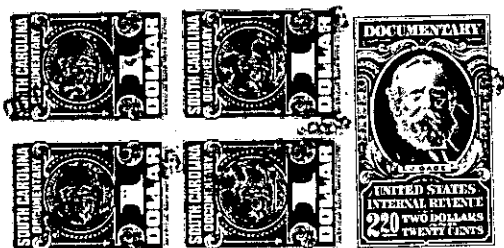
KNOW ALL MEN BY THESE PRESENTS, that I, Brown R. Bowie
