

ALSO, an undivided one-fifth interest in and to all right, title and interest in and to the common stairway and lobby of the building, situated on the above described lot and the buildings situated on the lot to the west thereof as acquired under the terms of a certain agreement between J. D. Neal and W. Marvin Pack dated July 18, 1924 and recorded in Deed Book 100, at Page 300.

ALSO, all that piece, parcel or lot of land situate, lying and being on the southern side of E. Court Street in the City of Greenville, County of Greenville, State of South Carolina and being known and designated as Lot No. 6 on the plat of property of C. C. Hindman, plat recorded in the R. M. C. Office for Greenville County in Plat Book "E", at Page 187, and, according to said plat, having the following metes and bounds, to-wit:

Beginning at an iron pin on East Court Street 80 feet from the East side of a ten foot alley; thence with East Court Street, S. 71-39 E. 25 feet to an iron pin, corner of Lot No. 7; thence with line of Lot No. 7, S. 18-21 W. 100 feet to an iron pin on 11 foot alley; thence with line of alley, N. 71-39 W. 25 feet to an iron pin, corner of Lot No. 5; thence with line of Lot No. 5, N. 18-21 E. 100 feet to the beginning.

ALSO, all that piece, parcel and lot of land situate, lying and being in Greenville County and having the following courses and distances and boundaries, to-wit:

In the City of Greenville on the East side of River Street fronting 95 feet on said street and having a depth of 90 feet, bounded on the North by a street and on the South by a Railroad siding being part of the E. M. C. Office for Greenville County in Plat Book G, at Page 139 and, according to said plat, having the following metes and bounds, to-wit:

Beginning at the corner of Hilltop Avenue and Edwards Street and running thence with Hilltop Avenue, N. 68 W. 100 feet to corner of Lot No. 8; thence with line of said lot, S. 13 W. 143.2 feet to an iron pin; thence S. 65-36 E. 100 feet to Edwards Street; thence with Edwards Street, N. 9-49 E. 150 feet to the beginning.
