in consideration of One Dollar and the cancellation of indebtedness in the amount of \$2,000.00 Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John S. Taylor, Jr., his heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 67, Section 1 on plat of Lake Forest, Plat of which is recorded in the R. M. C. Office for Greenville County, South Carolina in plat book "GG" at page 17, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the easterly side of Lake Fairfield Drive joint front corner of Lots 66 and 67 and running thence N. 86-30 E. 151 feet to an iron pin joint rear corner of Lots 66 and 67; thence S. 38-10 E. 85.3 feet to an iron pin joint rear corner of Lots 67 and 68, thence S. 64-30 W. 171.4 feet to an iron pin on Lake Fairfield Drive joint front corner of Lots 67 and 68; thence along Lake Fairfield Drive N. 23-26 W. 80 feet to a point; thence along Lake Fairfield Drive N. 17-33 W. 60 feet to an iron pin, the point of beginning.
