George M. Easler and Mamie Ruth Easler, their heirs and assigns, forever:

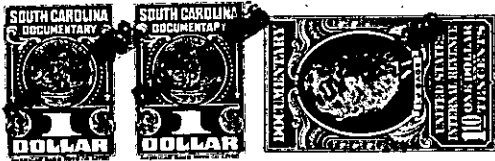
ALL that piece, parcel or lots of land in Chick Springs Township, State and County aforesaid, being known and designated as Lots No. 58 and 59 of a subdivision known as Holly Vista, as shown by a Plat thereof, dated February, 1956, recorded in the R.M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said Plat the following description, to-wit:

BEGINNING on Woodbriar Road at an iron pin at joint front corners of Lots 57 and 58 and running thence 130.8 feet, more or less, with the line of said Road to an iron pin at front corner of lot 59; running thence 172.3 feet, more or less, along the side line of lot 59 to an iron pin at joint rear corners of lots 59 and 60; running thence 67.3 feet, more or less, with the side line of lot 60 to an iron pin at joint corners of lots 57, 58 and 60; running thence 165.8 feet, more or less, with the side line of lot 57 to the iron pin at joint front corners of lots 57 and 58 on Woodbriar Road, the point of beginning.

NO residence to cost less than \$7,500.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 50 feet, or more, frontage; no residence shall be built on any lot nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is made subject to all easements and rights of way of record.
