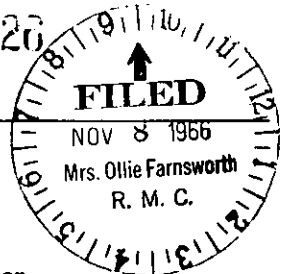

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marion W. Galloway and Vickie L. Galloway, their heirs and assigns, forever:

"ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville, in the subdivision known as Cherokee Park, and being known and designated as Lot No. 72 on a plat of said subdivision as recorded in Plat Book "C" at page 96 and having the following metes and bounds, to-wit: BEGINNING at an iron pin on the North side of Catechee Road, joint corner of lot of Rita B. Hart and the lot herein conveyed; thence with the northern side of Catechee Road, S. 75-45 W. 60 feet to an iron pin, corner of Lots Nos. 72 and 71; thence with joint line of said lots N. 14-15 W. 188 feet to an iron pin; thence N. 74-54 E. 60 feet to an iron pin, corner of Lot of Rita B. Hart; thence with the line of the lot of Rita B. Hart, S. 14-15 E. 188 feet to the point of BEGINNING; being the identical property conveyed to Home Building & Loan Association, Easley, South Carolina, by E.
