GRANTOR to pay 1966 taxes.

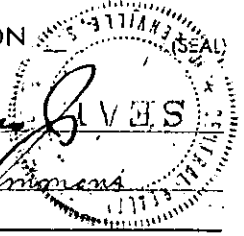
