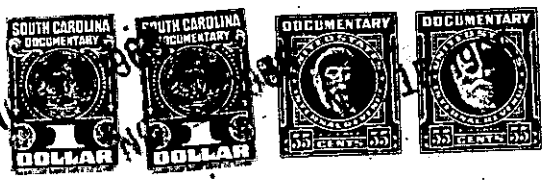
KNOW ALL MEN BY THESE PRESENTS, that, we, Walden Raines and Beatrice Page, Executors of the will of A.L.Ravan
