the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William C. Jones and Masako S. Jones, their heirs and assigns forever:

ALL that lot of land in Austin Township, Greenville County, State of South Carolina, just outside the corporate limits of the Town of Mauldin, shown as Lot 126 on plat of Glendale, recorded in plat book QQ at pages 76-77, and having the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Drury Lane at the joint front corner of Lots 125 and 126, and running thence with the northern side of Drury Lane, N. 74-53 W. 100 feet to a point at the joint front corner of Lots 126 and 127; thence N. 15-07 E. 171.3 feet to a point at the joint rear corner of Lots 126 and 127; thence S. 76-31 E. 100.04 feet to a point at the joint rear corner of Lots 125 and 126; thence S. 15-07 W. 174.2 feet to the point of beginning.
