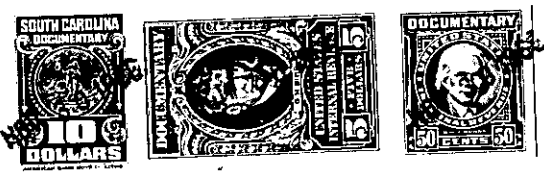
in consideration of ---FIVE THOUSAND AND NO/100 (\$5,000.00)----- Dollars,

ALL THAT CERTAIN piece, parcel or lot of land; situate, lying and being on White Horse Road, being a portion of Lot No. Sixty One (61) on plat of Earle Subdivision, PROPERTY OF LOOPER & YOWN, made by R. E. Dalton, Engineer, and recorded in the RMC Office for Greenville County in Plat Book "F", at Page 77, and having, according to said plat, the following metes and bounds, to-wit:
