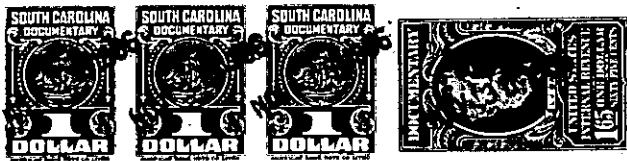
KNOW ALL MEN BY THESE PRESENTS, that I, Florrie E. Greer and William J. Greer

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Levis L. Gilstrap, his heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville, County, State of South Carolina, being known and designated as Lot No. 157 in the subdivision known as Eastdale Subdivision, Plat of said subdivision being recorded in the Greenville County R. M. C. Office and being more fully described as follows:

BEGINNING at an iron pin on the south side of Dellrose Avene at the joint front corner of Lots Nos. 157 and 158 and running thence along the joint line of said lots S. 21-49 W. 225 feet to an iron pin; thence N. 68-11 W. 100 feet to an iron pin; thence along the joint line of Lots Nos. 156 and 157 N. 21-49 E. 225 feet to an iron pin; thence along the south side of Dellrose Avenue S. 68-11 E. 100 feet to the point of beginning.
