KNOW ALL MEN BY THESE PRESENTS, that we, Richard F. Watson, Jr. and Evelyn P. Watson,

in consideration of Five Thousand and No/100-----(\$ 5,000.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Herman E. Cox and Doris W. Cox, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 53 of a subdivision of the property of the grantors as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Herman E. Cox & Doris W. Cox", prepared by Piedmont Engineers and Architects November 3, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Graystone Road, joint front corner of Lots Nos. 36 and 53, and running thence along the rear lines of Lots Nos. 36 and 37, N. 79-27 W. 243.45 feet to an iron pin at a rear corner of Lot No. 52; thence along the line of that lot, N. 12-08 E. 219.7 feet to an iron pin on the southern edge of Highbourne Drive; thence along the southern edge of Highbourne Drive, following the curvature thereof, the chords being S. 77-52 E. 34.2 feet and S. 74-01 E. 180.8 feet, to an iron pin; thence following the curvature of Highbourne Drive as it intersects with Graystone Road, the chord being S. 31-07 E. 36.7 feet to an iron pin on the western edge of Graystone Road; thence along the western edge of Graystone Road, following the curvature thereof, the chord being S. 10-57 W. 174.13 feet, to the beginning corner.

This conveyance is subject to utilities easements of record and is also subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 690, Page 531 as amended by subsequent restrictions recorded in Deed Vol. 758, at Page 116.
