R. Chandler by J. N. Bates, and others, by deed dated Oct. 1, 1940, recorded in the office of the R. M. C., Greenville County in Deed Book 249, at page 284. This conveyance is made by reason of the fact that T. R. Chandler, who was the grantee in the aforementioned property has recently died intestate leaving as his sole heirs at law, his widow, the grantee herein and his five children, the grantee herein and her brother, Melvin A.
