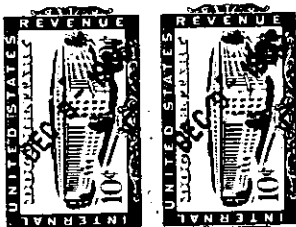
KNOW ALL MEN BY THESE PRESENTS, that I, R. D. Lunsford, and ALLIE F. WORTH R.M.C.

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Allie Inez R. Mathis

ALL that lot of land in the County of Greenville, State of South Carolina, in Bates township, in the Town of Travelers Rest, lying in the northwestern portion of the property shown on plat book H at page 59 as the property of Travelers Rest High-school, and also shown on a plat of property of Lee Roy Frazier by J. C. Hill, dated October 31, 1955. This is a portion of the property deeded to R. D. Lunsford by Lee Roy Fraizer and Grace M. Frazier, August 12, 1963 and Recorded in the R.M.C. Office for Greenville County on August 14, 1963 in Book 729 of Deeds, page 543, and this portion of property is shown on a plat of property of R. D. Lunsford by Terry T. Dill, dated August 30, 1963, and having, according to the latter plat, the following notes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Peterson Street, and running thence N. 43-50 W. 214.4 feet to an iron pin; thence running S. 48-50 W. 87.4 feet to an iron pin; thence running S. 36-15 E. 201.5 feet to an iron pin; thence running N. 53-38E. /to the beginning corner to an iron pin. 120 feet
