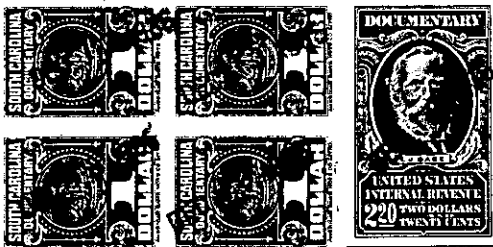
KNOW ALL MEN BY THESE PRESENTS, that I, James H. Holcombe
