That I, Beulah Brown Owens, formerly Beulah E. Brown - - - - - in the State aforesaid, in consideration of the sum of One Hundred Seventy Five and No/100 - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) George B. Wilbanks and Lola Mae Wilbanks, their Heirs and Assigns forever,

ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about four miles northwest of Greer, S. C., lying south from the Gilreath Mill Road and on the south side of a spring branch, and being a part of tract No. 1 as shown on Plat of Property of George T. Brown Estate made by H. S. Brockman, Surveyor, March 22nd 1949, which tract was conveyed to me in the division of the real estate of the said George T. Brown, deceased, by my sister, Pearl B. Stone, and having the following courses and distances, to wit:-
Beginning on an iron pin on the common dividing line of tracts 1 and 2 as shown on said plat, the said iron pin being S. 6-15 E. 59 feet from the corner of a tract conveyed by Pearl B. Stone to William S. Benson October 1957, and runs thence N. 6-15 W. 159 feet to an iron pin on the said line and on the south side of a spring branch; thence up the said branch, S. 85-35 E. 297 feet to an iron pin on the north side of the branch; thence S. 6-15 E. 150 feet to an iron pin; thence N. 87-22 W. 285.5 feet to the beginning corner, containing One (1) acre, more or less.

The grantor herein also agrees to give a road along the common dividing line of tracts 1 and 2 as shown on said plat, for the purpose of ingress and egress to the above described lot.

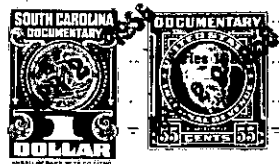
