Office for Greenville County in Plat Book X, at page 179 and, according to said plat, described as follows:

Beginning at an iron pin at the southwesterly corner of the intersection of Welcome Street and Welcome Road, and running thence along the southern side of said Welcome Road, S. 59-30 W. 166.7 feet to an iron pin, joint rear corner of Lots Nos. 8 and 9; thence along the joint rear line of said lots, S. 14-0 E. 32.8 feet to an iron pin, joint corner of Lots Nos. 9 and 10; thence along the line of Lots Nos. 9 and 10, N.72-27 E. 160.5 feet to an iron pin on the westerly side of Welcome Street; thence along the westerly side of Welcome Street, N. 14-0 W. 70 feet to the beginning corner, being the same property conveyed to Deles Boren by deed of Benjamin G. Boren dated July 6, 1964, recorded in the R. M. C. Office for Greenville County in Deed Book 753, page 316.
