KNOW ALL MEN BY THESE PRESENTS, that I, G. L. Foster,

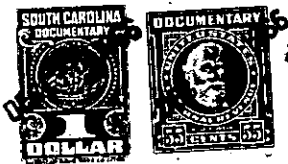

BEGINNING at an iron pin on the southern side of Manley Drive (formerly Crestwood Drive Extension) at the joint corner of property of the grantees and property of the grantor and running thence along the joint line of said property which is the eastern sideline of Lot No. 2 S. 22 W. 135.1 feet to an iron pin in line of Jamison property; thence N. 63-50 W. 100 feet along Jamison line to the joint rear corner of Lots Nos. 2 and 3; thence along the joint line of Lots Nos. 2 and 3 N. 26-10 E. 100 feet to an iron pin on the southern side of Manley Drive; thence along the southern side of Manley Drive S. 81-10 E. 50 feet to an iron pin; thence continuing along said Drive N. 88-10 E. 50 feet to the point of beginning.
