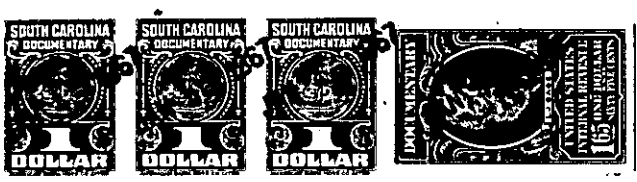
In consideration of Fifteen Hundred and no/100 (\$1,500.00) Dollars,
