in consideration of \$300.00 and assumption of mortgage in the amount of \$1,200.00--- Dollars,

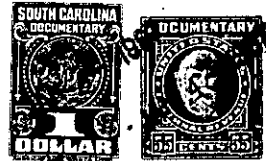
