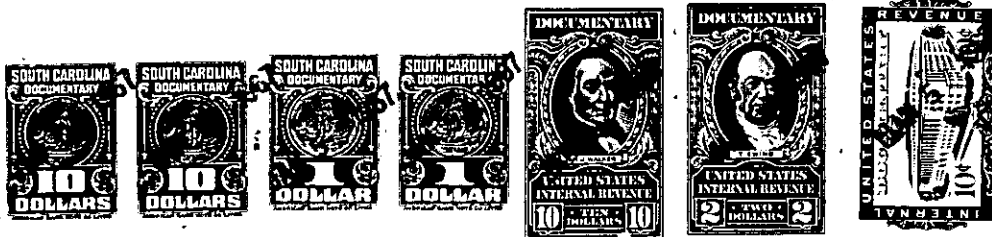

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto STEWART JOHNSON & MALINDA JOHNSON, their heirs and assigns forever;

ALL that lot of land with improvements lying on the Eastern side of Blossom Drive in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 34 on a Plat of KENNEDY PARK, made by Piedmont Engineers & Architects, dated September 28, 1964, revised January 28, 1966, and recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 179 and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of Blossom Drive at the joint front corner of Lots 33 and 34, and running thence along the common line of said lots, S. 87-05 E., 138.1 feet to an iron pin; thence S. 2-55 W., 23.8 feet to an iron pin; thence S. 2-38 W., 51.2 feet to an iron pin at the joint rear corners of Lots Nos. 34 and 35; thence along the common line of said lots, N. 87-05 W., 138.3 feet to an iron pin on Blossom Drive; thence along the Eastern side of Blossom Drive, N. 2-55 E., 75 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to utility rights of way, easements and building setback lines applicable to Kennedy Park, shown on the aforementioned recorded plat or otherwise appearing of public record and to restrictions applicable to Kennedy Park recorded in the RMC Office for Greenville County, S.
